- (a) This Application Form is to be completed in full and sent to Tauwhao Te Ngare Trust, PO Box 32, Tauranga 3144 or via email to coralie@tauwhaotrust.co.nz
- (b) The application must be accompanied by proof of enrolment for the current year, a <u>full</u> <u>Invoice for the current year</u>, and your previous year's academic results.
- (c) The applicant must submit a covering letter and a CV providing additional information to assist in the selection process.
- (d) The Tertiary Education Assistance Grant is available only to students undertaking a <u>full time</u> Degree or Diploma Course at a recognised Tertiary Institution.
- (e) The Applicant must be an owner or descendant of an owner in the Tauwhao Te Ngare Trust.
- (f) In order to receive an Education Grant, eligible applicants will need to confirm their attendance at the Trusts Annual General Meeting being held **9**<sup>th</sup> **October 2021.** If attendance in person is not practicable, a member of the applicant's whanau may attend on your behalf. Non representation at the AGM is deemed as not fulfilling the criteria.
- (g) The Selection Panel's decision is final and any incomplete applications will not be considered.
