In 2019 the Tauwhao Te Ngare trust approved a total 9 education grants for a total sum of \$13,000.00 Areas of study ranged from applied digital science to post graduate teachers undertaking their Masters with a number of various health professionals in the mix, from all the applicants the results they received in their first and second years of study were outstanding.

Applications will open again in early 2020 and the Trust would like to see more of our shareholders and their descendants apply, so keep an eye on our website for the 2020 application form.

Kaumātua Health Grants:

The trust offers health grants for sight, hearing and dental work to shareholders aged from 65 years. It is pleasing to see an increase of our kaumatua utilising this grant. Application forms for this grant can be found on our website.

Shareholders are encouraged to contact our trust office when they reach gold card status to ensure they are registered as a kaumatua, to automatically receive the annual kaumatua distribution application form which is posted out in late October of each year.

Tangihanga grants

Tangihanga Grants are available to the whānau of the deceased who was a beneficial owner or descendant of an owner as per the latest compiled list of owners from the Maori Land Court. The Grant is for a maximum of \$500.00. The application must be received within 12 months of the deceased passing away and the grant can be paid directly to the funeral homes or headstone providers IF that is the wish of the whānau.

Sport grant recipient feedback

Over the last few years the Trust has received sport grant applications from Kairangi and Anahera Koni who have whakapapa to Rangiwaea through the Tawhiti/Pakaru whānau. Anahera was featured as a national news story in 2016 when she hit a hole in one, on the fifth hole at Island Park Golf Club at the age of 6.

Earlier this year the Koni children participated at the U.S.Kids Australian Junior Golf Open at Riverside Oaks Golf Resort in Cattai, Australia. Their Dad Dan was very happy to send the Trust a report on how they placed at the tournament.

Anahera won the Girls 9 and Under age grade of two 9 hole rounds. She qualified 1st at the end of Day 1 (41) but on Day 2 the field fought back and competition was tough. It was a tense finish on the 9th hole. However, her 42 was enough to finish and to win by one shot overall.

Kairangi's competition in the Boys 10 grade was even tougher, but a 79 gross on Day 1 meant he was heading into the final round at 3rd position. By the end of the second day Kairangi had held his place to finish 3rd overall shooting a final round 76.

Overall, considering last year's results (2018), where Anahera was 3rd and Kairangi was 6th, it was pleasing for them to finish in high positions this year at 1^{st} place and 3^{rd} place respectively.

Firstly a sincere thank you to the trustees of Tauwhao Te Ngare Trust for providing a grant towards the costs for me to be a representative of the NZ junior women's Volleyball team that recently travelled to the United States of America.

We played a total of eight games, with five wins and three losses, (two of the losses we could've... should've won). We were placed tenth overall out of 15 teams in our division. Although this doesn't sound great on paper, our coaches were pleased as this was the best any NZ team had placed at the tournament in a very long time. One main difference we found in playing the USA teams was that they played with pace and such precision. In the USA they play volleyball from a very young age and in schools it is played almost all year round. They are definitely not restricted by limited budgets.



We met a number of players and coaches from lots of different backgrounds and cultures, who were just as interested in us Kiwi's, as we were in them. Some USA girls were already in the process of signing scholarships with some of the big volleyball colleges, e.g. Stanford, UCLA.
